
1 I, CURTIS W. CANNON, hereby declare under penalty of perjury
2 according to the law of the State of Nevada as follows:

3 1. I am the sole officer, director, and stockholder of Curtis W.

6 and I make this Declaration in opposition to the Motions to Strike and

9 Motion to Clarify the Court's May 28, 2008 Decision. During the
