AFFIDAVIT OF KENNETH F. WRIGHT AKA KEN WRIGHT

I, Kenneth F. Wright, being first duly sworn upon oath depose and state as follows:

1. Several years ago I purchased 1,000 shares in Explorations, Inc., of Nevada. The purchase was made in either two or three parts. Once I had accumulated 1,000 shares, Company President Larry Hahn issued a stock certificate to me for 1,000 shares of Explorations, Inc., of Nevada, which was signed by both himself and Board Member Jimmy Serrill. The image of that stock certificate can be found on the Kokoweef, Inc., website, www.kokoweef.com in the Kokoweef Access photo section.
2. During a subsequent annual shareholder meeting held in June (I don't recall the year) at the Big House on the Kokoweef property, I purchased 100 additional shares of Explorations, Inc., of Nevada, for \$600 total. I cannot seem to locate the receipt for the purchase of those 100 shares. I believe I may have mailed it to Larry Hahn with my stock certificate for 1,000 shares of Explorations, Inc., of Nevada (see Item 6, below). This brings my total number of shares of Explorations, Inc., of Nevada to 1,100 shares.
3. Two years ago, I built the website for Kokoweef, Inc. Company President Larry Hahn had originally promised to issue me 100 shares of Explorations, Inc., of Nevada to build the www.kokoweef.com website as a planned compensation for my work. I never received the 100 shares of Explorations, Inc., of Nevada stock after I completed the website work on www.kokoweef.com. This promised issue of 100 shares of Explorations, Inc., of Nevada would have brought my total shares of Explorations, Inc., of Nevada to 1,200 shares.

4. I had paid A1 Net Hosting for two years of webhosting the www.kokoweef.com website with two separate payments. The first payment of \$299.88 was made on June 30, 2006. The second payment of \$299.88 was made on January 16, 2007. The cost for webhosting www.kokoweef.com was \$299.88 per year, therefore, the total amount I paid A1 Net Hosting was \$599.76 (a mere \$0.24 short of \$600 to go for the purchase of 100 shares of Explorations, Inc., of Nevada). In order to provide me reimbursement for paying for the webhosting of www.kokoweef.com, Company President Larry Hahn told me that he was sending me a check for \$600 from Explorations, Inc., of Nevada as reimbursement for my payment to A1 Net Hosting for the two years of webhosting www.kokoweef.com and that, if I wanted 100 shares of Explorations, Inc., of Nevada stock in lieu of the \$600 cash reimbursement, I should endorse the check, make it payable to Explorations, Inc., of Nevada and send it back to him. Larry Hahn told me he wanted to issue the 100 shares in this manner and have the cancelled check as a record for bookkeeping. I received the check in the mail, a check for the amount of \$600.00 from Explorations, Inc., of Nevada, Check # 5105, written out to "Ken Wright" for "W W Web Work." As directed by Larry Hahn, I endorsed the check and signed it back to Explorations, Inc., of Nevada, and mailed it back to him in order to purchase the 100 shares of Explorations, Inc., of Nevada stock. I had never received the 100 shares of stock that I, supposedly, purchased, by sending the endorsed check back to Larry Hahn. Incidentally, the two years webhosting of www.kokoweef.com expired in June of 2008. Payment is currently required for renewal. I will be making payment this week. I have included, with this affidavit, a copy of an email that I sent to Richard Dutchik, dated January 19, 2007, carbon copying Larry Hahn that included images of the two paid invoices from A1 Net Hosting for two years of


webhosting www.kokoweef.com and a copy of the \$600.00 check from Explorations, Inc., of Nevada, signed by Larry Hahn. The 100 shares of Explorations, Inc., of Nevada stock would have brought my total shares of Explorations, Inc., of Nevada stock to 1,300 shares.

5. After some time had passed since the www.kokoweef.com website was up and running, Larry Hahn, Richard Dutchik, and I were on a three-way telephone call. Larry Hahn was very happy with how the website turned out and recognized that the effort I put into building it was worth much more than the original 100 shares of Explorations, Inc., of Nevada stock. During that three-way telephone call, Larry Hahn agreed to give me an additional 1,200 shares of Explorations, Inc., of Nevada to reward me for the excellent job I did in building the www.kokoweef.com website and for the work I was doing on a continuing basis to maintain the www.kokoweef.com website with updates from Kokoweef management (e.g., Shareholder Newsletters from President, etc.) with the agreement that I would take responsibility for maintaining the website indefinitely. I have never received the original 100 shares of Explorations, Inc., of Nevada as verbally contracted for building the www.kokoweef.com website as noted in Item 3, above. I never received the additional 1,200 shares promised to me for my work and my commitment to perform the continued maintenance on the www.kokoweef.com website on an indefinite basis. If I include only the 200 shares promised for building and webhosting the www.kokoweef.com website noted in Items 3 and 4, above, my total shares of Explorations of Nevada, Inc., is 1,300 shares. If I had also received the additional 1,200 shares promised to me by Larry Hahn and witnessed by Richard Dutchik, my total shares of Explorations of Nevada, Inc., would be 2,500 shares.

6. Company President Larry Hahn issued a letter to shareholders on October 26, 2006, to turn in their Explorations, Inc., of Nevada stock certificates in order to exchange them with a new Kokoweef, Inc., stock certificate of equivalent shares. Because I had not yet submitted my Explorations, Inc., of Nevada stock certificate at the time I made the second payment for webhosting the www.kokoweef.com website, Larry Hahn requested I turn in my Explorations, Inc., of Nevada stock certificate for 1,000 shares as soon as possible and told me that I would receive a stock certificate for 2,500 shares in Kokoweef, Inc., which would include the 1,000 shares from my original certificate, the 100 additional shares I purchased at the annual shareholders' meeting, the initial 100 shares promised to me for building the www.kokoweef.com website, the 100 shares to reimburse me for my paying for the www.kokoweef.com webhosting for two years, and the additional 1,200 shares after the fact for building the www.kokoweef.com website and maintaining it indefinitely. To this day, I have received nothing for turning in my certificate or any of the other shares purchased or promised.
7. It should be noted that the copy of the check for \$600 I discussed in Item 3, above, and the copy of the email from Richard Dutchik with the A1 Net Hosting website invoices I discussed in Item 4, above, were actually attachments of a letter from Larry Hahn demanding me to shut down the www.kokoweef.com website claiming that Larry Hahn and Kokoweef, Inc., owns the www.kokoweef.com website because I was already reimbursed for the webhosting of the www.kokoweef.com website. This "harassment letter" was sent to me Certified Mail after Larry Hahn was directed by attorney Neil J. Beller, representing Ted R. Burke, Michael R. and Laurretta L. Kehoe, etc. to cease any harassment to either Richard Dutchik or myself regarding the operation of the


www.kokoweef.com website and direct any further issues regarding the website to him via his attorneys.

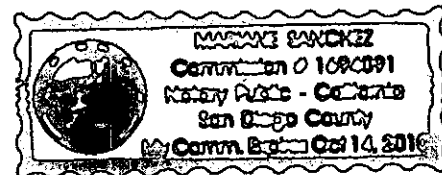
8. I am also personally aware, first hand, that Dr. J. Michael Ernest made a payment of \$600 for the purchase of 100 shares of Explorations, Inc., of Nevada in June 2006 at the shareholders' meeting held at Kokoweef Mountain because Dr. J. Michael Ernest and I rode together from North San Diego County to Kokoweef Mountain to attend that shareholders' meeting. To this day I am personally aware, first hand, that Dr. J. Michael Ernest has never received a stock certificate for the 100 shares that he purchased at that shareholders' meeting.

We request that you remove the web site you designed and destroy any and all proprietary information that was put on the site.

The site is no longer the official website for Kokoweef Inc. Although, Richard Dutchik owns the web address, he does not own the proprietary information or the site as it was designed, nor does Richard Dutchik have the right to act as if, www.kokoweef.com is in any way shape or form associated with or represent itself as being supported and/or approved by Kokoweef, Inc. Also, Ted Burke is no longer the Vice President and has no right to place information on the web site designed and paid for by Kokoweef, Inc.
