**Lawsuit:** On another note, we have problems to overcome. Our former Director and Secretary, Ted Burke, and a few fellow investors that he brought on board began a lawsuit in March 2008. In the lawsuit they accuse me of misappropriating funds and living high on the hog. On June 30,08 there was an Evidentiary Hearing in District Court in which we, the Defendants carried the burden of proof to show that no monies were missing. The Judge ruled, there was no misappropriation of funds. He also assigned a \$75,000 bond **against** Mr. Burke and the other plaintiffs for court costs and attorney fees. 
